We began 2023 facing significant organizational challenges, yet we were determined to rebuild and strengthen our team cohesion while aligning our program work more effectively. By the end of the year, we had achieved substantial progress across our climate, sustainability, and GGHH network programs. With the guidance of the Board, we initiated several strategic and consolidating actions, including the establishment of sustainability funds, the creation of the Management Committee, staff regularization evaluation, and enhancements to staff well-being.

Our key accomplishments in 2023 were driven by the dedication and expertise of our program officers and managers. As detailed in this report, our climate program was relentless in pursuing strategic partnerships, forming key alliances with regional Ministries of Health and the WHO on a global scale. GGHH in Southeast Asia launched the region's first coordinating council, setting a precedent for the entire global network. The sustainability unit successfully secured a project to campaign for the Global Plastic Treaty within the healthcare sector.

Our communications team, after overcoming initial disruptions, delivered great work, while our administration and finance unit improved responsiveness with the addition of new staff. The most significant hire of the year was our Fundraising Manager, whose role will be pivotal in ensuring our organizational sustainability in the coming years.

Overall, 2023 was a remarkable year. We extend our deep gratitude to our partners in the healthcare sector, the leaders, and every individual in the institutions we collaborated with. It is with great pride that we present the recap of 2023 in this annual report.

# **About Health Care Without Harm**

First, do no harm.

Health Care Without Harm (HCWH) is an international nongovernmental organization that works to transform health care worldwide so that it reduces its environmental footprint, becomes a community anchor for sustainability, and leads in the global movement for environmental health and justice.

Together with our partners around the world, we share a vision of a health care sector that does no harm, and instead promotes simultaneously the health of people and the planet. To that end, we are working to implement ecologically sound and healthy alternatives to health care practices that pollute the environment and contribute to disease.





## About Health Care Without Harm Southeast Asia



Healthy Planet, Healthy People

In 2003, HCWH Southeast Asia (HCWH SEA) started with the commitment to improve health care systems in countries in the region. The group's first project in the area was the Philippine Measles Eradication Campaign (PMEC, which demonstrated the possibility of conducting a major immunization campaign without incinerating the resulting waste. The project set a global benchmark that was cited in international conferences. In 2006, the issue of mercury in medical and science equipment came into focus. The organization held the first mercury conference in Southeast Asia.

Today, HCWH SEA is focused on three major programs: Climate and Health, Sustainability in Healthcare, and the Global Green and Healthy Hospitals network. We steadfastly uphold the organization's mission to champion people's right to health and a healthy environment, leading healthcare sector transformation in the region towards climate resilience, decarbonization, and sustainability. HCWH SEA aims that by 2029, we will have accelerated the progress of health care transformation in the region, through partnerships, platform for collaboration, and policy advocacy.

# The Year at a Glance

#### **OUR 2023 TIMELINE**

2023 was a pivotal year for us at HCWH SEA. Alongside our ongoing programmatic and secretarial efforts, our team has been diligently developing a five-year strategic plan. Early in the year, we initiated the conceptualization of a revamped strategy that will guide our work from 2024 to 2029.



#### **REGION**

MOU signing between HCWH SEA and Sunway Centre for Planetary Health (SCPH) to tackle the pressing issue of climate change and its impact on human health in Southeast Asia.

#### **GLOBAL**

Our team participated in the 2023 Prince Mahidol Award Conference in Bangkok. The global multi-stakeholder forum was co-hosted by the Prince Mahidol Award Foundation, the Government of Thailand, and other partners. Our Executive Director and Regional Climate Manager participated in UNDP's two parallel sessions: "Multi-sectoral Policies and Practices: Mitigation" and "Multi-sectoral Policies and Practices: Adaptation."





#### **FEBRUARY**

#### **REGION**

HCWH SEA Executive Director joined a panel organized by #BreakFreeFromPlastic (BFFP) and Climate Tracker Asia, which explored the relationship between plastic pollution and the climate crisis, the impacts of plastics on human health, and the need for corporate accountability and genuine solutions.

#### **INDONESIA**

As a new organizational member of the Climate Action Network Southeast Asia (CANSEA) Node, our Regional Climate Manager participated in the Annual Strategy Meeting and General Assembly of the Climate Action Network (CAN), a global network of more than 1,900 civil society organizations in over 130 countries driving collective and sustainable action to fight the climate crisis and to achieve social justice.

#### **PHILIPPINES**

Our Regional Climate Manager, together with allies from the medical community, participated in a consultation with the Department of Environment and Natural Resources' Environmental Management Bureau to discuss updating air quality guideline values for additional hazardous pollutants in the country.





#### **REGION**

An exclusive interview with our Executive Director by GovInsider Asia about the "One Health" approach to greening hospitals – how public and environmental health are interconnected, paving the way for a healthier future.

#### **MALAYSIA**

We successfully completed our first ever virtual basic orientation for healthcare professionals on "Climate and Health Advocacy and Communication," a joint collaboration with SCPH.



#### **PHILIPPINES**

HCWH SEA and Ecowaste Coalition conducted a Plastics Strategy Meeting in which outcomes were agreed upon, including: amplifying health voices, plastics and health leadership hub, and plastics and health articulation.

#### **INDONESIA**

As part of our collaboration with the Cities Finance Facility (CFF) of the C40 in Jakarta, we conducted a 2-day Carbon Footprint Café, a training on greenhouse gas (GHG) emissions assessment using HCWH's Climate Impact Checkup (CIC) tool with participants from the provincial government of Jakarta and its public hospitals.

#### **APRIL**



#### **TAIWAN**

We conducted our 5th country-based Carbon Footprint Café with representatives from 25 Taiwanese hospitals where they learned how to calculate their facility's carbon footprint and develop their mitigation action plan.

Race to Zero (RtZ) members from Southeast Asia also joined the first ever regional learning session that aims to provide a set of recommendations for the sector to guide RtZ participants on how to approach their net-zero commitment and be successful.

#### **THAILAND**

Our team participated and facilitated a weeklong training organized by Asian Development Bank (ADB) and the Thai Ministry of Public Health (MOPH), "Planning Workshop on Making Thailand's Medical Excellence Centers Climate-Smart and Disaster-Resilient."

#### **VIETNAM**

Our staff participated in the Break Free From Plastics (BFFP) Global Assembly, and the Global Anti-Incinerator Alliance Asia (GAIA) Pacific Regional Meeting held in Hoi An. This also gave us the opportunity to initially meet with Health Environment Management Agency (VIHEMA) for potential hosting of the 6th Green Hospital Asia Conference in 2024.

**MAY** 

#### **REGION**

The team gathered for a few days for a team retreat where an intensive feedbacking session and an interactive workshop on compassion and self-care were organized.

#### **GLOBAL**

Represented by our Regional Climate Manager, we joined representatives from Race to Zero hospitals including organizations part of Global Green and Healthy Hospitals (GGHH) and Practice Greenhealth network in Pittsburgh, USA for the global gathering for health care climate action and CleanMed US Conference.





#### **REGION**

Together with the Columbia University Mailman School of Public Health, and the Global Health Program of St. Luke's Medical Center College of Medicine-College of Medicine, we launched the month-long Southeast Asia Climate and Health Responder Course, aiming to empower healthcare professionals and institutions to tackle the challenges at the crossroads of climate, environment, and health using a transdisciplinary approach.

#### **TIMOR-LESTE**

Our team went to Timor-Leste, a member of the Alliance for Transformative Action on Climate and Health, to provide technical support to the Ministry of Health (MOH) and the World Health Organization (WHO) in assessing the climate vulnerability of healthcare facilities and co-develop policy priorities and strategies for improved climate resilience and environmental sustainability in healthcare.



#### **PHILIPPINES**

Our Executive Director, with colleagues from the Private Hospitals Association Philippines, participated at the Visayas Regional Management Seminar in Cebu City to present, "Zero Waste in Hospitals," which focused on the impact of waste within the healthcare sector, common myths surrounding zero waste, and practical solutions for sustainable management of COVID-19 healthcare waste.

#### **PHILIPPINES**

Our Healthcare Waste Sustainability Officer was invited as a speaker by Panatag Luntian in their webinar entitled "Plastic, Not-So-Fantastic: A Webinar on Exploring Solutions to #BeatPlasticPollution," and shared about the case studies of healthcare waste management in the health sector.

#### **REGION**

Together with SCPH, we organized a webinar on, "Transforming Healthcare Waste: Sustainable Practices for a Healthy Future," delving into the importance of proper waste management in safeguarding the health of patients, health workers, and the general public.



#### **JULY**

#### **PHILIPPINES**

We organized a Policy Forum, "Addressing Plastic Waste Pollution in Healthcare Facilities," with the Department of Health (DOH) Center for Health Development NCR and BFFP. Bringing together multi-sectoral stakeholders, the event follows the Intergovernmental Negotiating Committee session in Paris, where efforts were made to develop a global, legally binding instrument on plastic pollution.



#### **REGION**

As we hit the midway point of the year, the team had an intensive week of discussions, reflecting on our achievements so far and planning for the months ahead. During this time, we also started the discussion on the establishment of our 5-year organizational strategic plan (2024-2029). Apart from the strategy meetings, it also presented an opportunity for the team to take a break from work and bond.



#### **INDONESIA**

In collaboration with the Indonesian Health Promoting Hospitals Network and funding from the TARA Climate Foundation in Indonesia, we officially launched Kesehatan Untuk Bumi (KEBUMI), an initiative through the RISE Southeast Asia Alliance for Health and Climate that aims to empower health professionals in the country to be at the forefront of the climate discourse.



#### **REGION**

We participated at the WHO South-East Asia Region (SEARO) in Bangkok where our Sustainability team conducted a session titled "Waste prevention and reduction, recycling and reuse in health care facilities- Policies, Standards, and guidelines to promote a circular economy model."



#### **THAILAND**

Our Executive Director visited Bangkok as part of the climate adaptation consultant team for a project with the Asian Development Bank. Working closely with Thailand MOPH, this innovative project aims to build five Medical Excellence Center (MEC) hospitals across five provinces in the country.

#### **AUGUST**



#### **PHILIPPINES**

HCWH SEA launched the Health Alliance for Climate and Clean Air Philippines (HACCAP), a collaboration between health organizations (Philippine College of Chest Physicians, Philippine College of Physicians, Philippine Society of Allergy, Asthma and Immunology, and Lung Center of the Philippines) committed to taking the lead in addressing climate change and air pollution, particularly in the healthcare industry.

#### **REGION**

We released a short animated video documentary titled <u>"We Need to Talk About Gloves,"</u> shedding light on a crucial yet often overlooked issue on single-use waste in the healthcare industry.

#### **MALAYSIA**

We organized the first ever Climate Change Campaign and Advocacy Training in Kuala Lumpur using the recently published "Health Activism in the Age of the Climate Crisis: A guide to effective campaigning and advocacy for health professionals." Through the collaboration between the Ministry of Health, SCPH, and HCWH SEA, the goal was to equip health professionals in Malaysia with communication skills for climate and health campaigning.

#### **PHILIPPINES**

Through our BFFP membership, we joined the in-person consultation with the Commission on Energy on the proposed bill on national energy policy and regulatory framework for facilities utilizing waste-to-energy technologies. Recalling the precautionary principle, and the health impacts of incineration technologies, HCWH SEA and local CSOs, opposed the bill to protect the health and the environment.

#### **PHILIPPINES**

We conducted a one-day healthcare waste management training and site assessment in one of our Global Green and Healthy Hospitals members, James L. Gordon Hospital.

#### **SEPTEMBER**

#### **PHILIPPINES**

During the International Day of Clean Air for Blue Skies, HACCAP brought its members, other medical organizations, climate and environmental groups, and government stakeholders together for a policy roundtable discussion, focusing on how the alliance can advocate and lobby for better policies, specifically centered around safeguarding public health through concerted efforts in clean air and climate action.

#### **GLOBAL**

Our Sustainability Officer delivered a statement on our journey towards achieving sound chemicals management in the health care sector during the International Conference on Chemicals Management's fifth session in Bonn, Germany. We participated in the ICCM-5 until the finalization of the Global Framework on Chemicals.



#### **PHILIPPINES**

We kicked off the series of activities under a pilot project with FHI 360, aimed to build resilience in the healthcare sector and reduce its climate impact. Guided by the Philippine Department of Health's Green and Safe Health Facility Manual and several HCWH resources, we worked closely with three facilities in the Philippines for weeks of training sessions, interviews and focused group discussions, and facility visits and assessment.

#### **OCTOBER**

#### **THAILAND**

Our Executive Director visited the five identified MEC hospitals to discuss plans under the ADB/MOPH partnership, which aims to build climate-smart and resilient MECs in five provinces of Thailand. The visit paved the way for three of the five hospitals to commit not only to the GGHH network but as well as to the Race to Zero initiative.

#### **VIETNAM**

Our team visited Hanoi to formally negotiate the hosting of the Health Environment Management Agency (VIHEMA) of the 6th Green Hospitals Asian Conference (GHAC) in the 4th quarter of 2024, and consolidate partnerships among other GHAC organizers.

#### **PHILIPPINES**

Sr. Arcelita Sarnillo, an active RISE ally representing our GGHH member St. Paul's Hospital in Iloilo won the 2023 Philippine Resilience Awards for Women, recognized for her unwavering dedication to climatesmart and green healthcare advocacy.

#### **PHILIPPINES**

We co-organized the 9th Population, Health, and Environment National Conference in Iloilo City. The 2023 leg of the conference aimed to explore how integrated PHE strategies can transform challenges into opportunities and promote resilience and economic growth in the new normal.



#### **NOVEMBER**

#### **REGION**

Our climate team organized the "RISE Round Robin: regional updates and priority setting for South East Asia," a virtual event aimed at fostering an inclusive and interactive climate-health dialogue among members of the alliance.

#### **REGION**

HCWH SEA was invited to the CSO workshop for the Global Plastics Treaty in Jakarta, Indonesia. They were able to make their case on how health should be at the center of the Plastics Treaty, and how crosscutting collaboration including the health sector is needed.

#### **SINGAPORE**

We organized another 2-day Carbon Footprint Café session this time with our GGHH members and partners in Singapore, strengthening their capacity to calculate their GHG emissions and implement low-carbon, sustainable, and climate-resilient initiatives at their facility or institution.

#### **REGION**

HCWH SEA participated at the Asia-Pacific Climate Week in Johor Bahru. In collaboration with Melbourne Climate Futures of the University of Melbourne, FHI 360 Asia Pacific, and the UN Framework Convention on Climate Change, we hosted a session "Resilient Health Systems: Localizing Climate Policies and Tools for Accelerated Action," to emphasize the cross-cutting nature of health and highlight strategies to address the climate crisis while underscoring the role of health as a driver for collective climate action. Plus, together with SCPH, we organized an Action Hub session, "Climate and Health," where an interactive conversation with healthcare professionals, climate activists, and communities took place.



#### **PHILIPPINES**

We attended the 11th Better Air Quality Conference in Manila, where leaders, experts, and advocates united for clean air and a healthier climate. Our ED joined a panel on, "Stakeholders Working Together to Achieve Clean Air for Health and Climate."



#### **REGION**

The "Green Hospitals in Southeast Asia: Sustainability Best Practices in Healthcare" compendium was launched. From reducing carbon footprints efforts to innovating waste management solutions, these case studies highlight the inspiring commendable work of various healthcare facilities in Southeast Asia.

#### **REGION**

Together with the University of the Philippines Manila College of Public Health (Department of Environmental and Occupational Health), our team co-organized the 6th Environmental and Occupational Health Forum, which focused on discussing how to accelerate the development of healthy and climate-smart hospitals in Southeast Asia, particularly supporting SDGs 3, 8, and 11.

#### **REGION**

Gearing up for COP28 and in celebration of the third anniversary of RISE South East Asia Alliance for Health and Climate, our climate team held the "#Health4Climate RISE Celebration and COP28 Countdown." We partnered with Parabukas to capacitate RISE allies and stakeholders to understand and get involved in multinational events (e.g. COP) and give them access to opportunities in contributing to strengthening health's voice. It also provided an avenue for them to learn about how health has been integrated in the Nationally Determined Contributions and National Adaptation Plans.

#### **REGION**

A week before COP28, we launched the "Briefer for Health Professionals." Tailored for our health community in Southeast Asia, the document contains primary information about the annual conference; how health is integrated in the discussion and agreements made by the member states at these conferences; and, why/how the health sector needs to be aware and be part of these global climate negotiations.

#### **PHILIPPINES**

The Exit Conference for our productive project engagement with FHI 360, the Green and Safe Facility Initiative, took place. The event was a reunion with the three participating facilities and a moment for reflecting on our joint efforts — the months of training sessions, consultations, facility assessments, and reporting.



#### **DECEMBER**



#### **REGION**

Members of the GGHH network gathered for a year-end celebration. It was an interactive virtual event where attendees reflected on their 2023 sustainability achievements and challenges.

#### **GLOBAL**

Our climate team joined HCWH's 12-person global delegation at COP28. 2023 was a historic moment at the annual climate conference, hosting its inaugural Health Day. Organizations representing over 46 million health care professionals called for the phasing out of fossil fuels by signing the <a href="COP28">COP28</a> Health Open Letter. #### **PHILIPPINES**

Along with other CSOs, we met with the Mayor of Quezon City to bring the agenda of Zero Waste Cities. We also presented our position paper and our calls to action on the proposed bill related to waste-to-energy technologies.

#### **REGION**

The team concluded the year with a weeklong gathering in Baguio City, Philippines. The days were packed with a series of meetings, reflecting, and feedbacking on the 2023 work plan, and preparing for the following year. A mini Christmas party was organized as well.



# Program Highlights



In 2023, our focus remained on furthering the progress of our core programs: Climate and Health, Sustainability in Healthcare, and the Global Green and Healthy Hospitals.

For a small team working to advance an ambitious advocacy of leading the transformation of the healthcare sector in the region towards environmental health and justice, the past year has been challenging and fulfilling at the same time. From onboarding new team members and launching new partnerships, to wrapping up projects and adjusting our strategies – 2023 has been productive. Together with our support units (Administrative, Finance, Fundraising, and Communications), we ended the year optimistic about the year ahead.



### Climate & Health

#### **Milestones and Impact**

In our Climate and Health program, we have made significant strides towards proactive engagement and cross-sectoral collaboration, from the community level with health professionals, to the facility level with health organizations, and up to the national and global level with government institutions in Southeast Asia.

At the facility level, we have supported the implementation of climate initiatives under our GGHH network, developing the capacity of our members to conduct a baseline of their GHG emissions and supporting our Race to Zero (RTZ) participants in the development and implementation of their action plan. Our training of trainers (TOT) approach has proven to be an effective capacity development strategy where learning and collaboration between members are encouraged and supported.

Our engagement with Ministries of Health significantly strengthened in 2023. With our influence, we witnessed a 100% increase in country-level commitments to the COP26 Health Programme and membership to the Alliance for Action on Climate Change and Health (ATACH) from Southeast Asia compared to 2023. By the end of 2024, Brunei, Philippines, and Vietnam joined Lao PDR, Indonesia, and Timor-Leste in the list of member countries from the region, committed to building climate-resilient, low-carbon, and sustainable health systems.

Another evident manifestation of our influence at the country-level, was when nine ministries from our region endorsed the inaugural <u>Climate and Health</u> <u>declaration</u> at COP28 – we helped secure six of them (Philippines, Vietnam, Lao PDR, Indonesia, Brunei, and Timor-Leste).

At the beginning of the year, we started working with MOH Timor-Leste and WHO Timor-Leste, supporting them in their commitment to develop climate-resilient and environmentally-sustainable health facilities in the country. By the end of the year, our team kicked-off another official collaboration, this time with the Department of Health in the Philippines. This project aims to provide capacity development support to their health facilities and regional offices of GHG emissions assessment, potentially integrating HCWH's Climate Impact Checkup (CIC) tool into the required reporting requirements of public hospitals in the country.

For our work with health professionals, the creation of the Regional Committee of the RISE Southeast Asia Alliance for Health and Climate marked a strategic shift towards a more proactive and tailored collaboration with health professionals in the region. Through establishing two health-climate alliances in Indonesia (Kesehatan Untuk Bumi or KEBUMI) and the Philippines (Health Alliance for Climate Clean Air Philippines or HACCAP), we were able to build health professional leadership in advocating for key climate and health issues, whilst expanding our partnerships with environmental organizations and government bodies in Southeast Asia.

In the last quarter of the year, we participated at the United Nations Climate Change Conference (COP28), which marked a historic milestone with the inaugural Health Day at the annual Conference of Parties. Alongside HCWH's 12-person international delegation, our regional climate team organized and participated in numerous events in collaboration with partners from governments, private institutions, and other NGOs. The core message of our COP28 work revolved around the COP28 Health Open Letter.

Key partnerships with regional bodies like WHO Western Pacific Region (WPPRO) and South-East Asia Region (SEARO), Climate Action Network Southeast Asia (CANSEA), as well as collaborations with organizations like the Sunway Centre for Planetary Health (SCPH), Parabukas, the Indonesian Health Promoting Hospital Network (IHPH-Net), Cities Finance Facility (CFF), among others enhanced the impact of our work in the region.

The expansion of our team, through the hiring of our Climate Officer based in Indonesia, was a key factor in furthering our 2023 Climate-Health work in the region.

### Sustainability in Healthcare

**Milestones and Impact** 

Over the past year, we have achieved significant milestones in our efforts to address sustainability challenges within the healthcare sector.

As part of our intensive three-year project with the #BreakFreeFromPlastic in partnership with fifteen hospitals in the Philippines, we successfully conducted the "Protecting Health, Protecting Our Planet: Addressing Plastic Waste Solution in Healthcare Facilities" policy forum. The event marked the conclusion of our collaborative project that aimed at engaging the country's healthcare sector in advocating for public policies that prevent plastic pollution and discourage false solutions.

Collaborating with the GGHH and Climate programs, we launched the "Green and Safe Health Facilities Initiative" project in partnership with FHI 360, emphasizing sustainability practices in healthcare facilities in the Philippines. Working with three facilities in the National Capital Region, we were able to provide capacity-building sessions, site assessments and data collection, and reporting and evaluation support. Additionally, we resumed work on a proposal to address healthcare waste and mercury waste in collaboration with GEF UNIDO.



The "Philippines COVID-19 Response Project: Third-Party Audit on Healthcare Waste Management Compliance of Selected Healthcare Facilities" confirmed the findings of the pilot implementation of the "COVID-19 Waste Management Self-Assessment - Compliance Audit Checklist." Subsequently, a Third-Party Compliance Audit (TPCA) on healthcare waste management systems of selected healthcare facilities was initiated. This project aimed to offer an insight into the healthcare waste management systems in the Philippines and their alignment with DOH policies.

While the program's 2023 work mainly focused in the Philippines, we also extended our effort to the rest of the region. We went to the WHO SEARO Regional Meeting and the CSO Workshop for Global Plastics Treaty, where we contributed to developing a proposal to tackle the issue of single-use plastics. Moreover, we collaborated with key partners in the region such as SCPH in Malaysia for a webinar on the importance of proper waste management in safeguarding the health of patients, health workers, and the general public. At the international level, we joined global conferences such as the SAICM International Conference for Chemicals Management.

Throughout the year, we produce publications to strengthen our Sustainability in Healthcare voice on public platforms including <u>a video documentary on gloves</u> and policy papers on <u>single use plastics</u>, incineration technology, the Waste to Energy (WTE) bill in the Philippines, and the Global Plastics Treaty.



# Global Green and Healthy Hospitals

#### **Milestones and Impact**

2023 was a progressive year in network building for the Global Green and Healthy Hospitals (GGHH) in the region. Our GGHH community continued to grow in countries within and outside Southeast Asia. Eleven healthcare institutions committed and joined the network last year:

Active membership engagement has been another focus throughout the year, with targeted efforts to reactivate and involve dormant members, notably in Taiwan and the Philippines.

We expanded our reach through successful initiatives in key countries like Taiwan, Vietnam, and Thailand. In Vietnam for instance, our collaborations with the Vietnam MOH through its Health Environment Management Agency (CHERAD), has set the stage for increased influence in the Mekong Region. Meanwhile, our reconnecting efforts in Thailand continued to be underway, leveraging relationships with new Race to Zero members in the country.

Leadership development has also been a top priority in 2023. One major highlight is the convening of the Regional Coordination Council of the network and the start of their involvement in setting strategic directions. The creation of a 5-year Strategic Plan, guided by GGHH leaders, underscores our commitment to consistent growth and impact. Also in 2023, we published the "Green Hospitals in Southeast Asia: Sustainability Best Practices in Healthcare," a compendium of case studies highlighting the commendable efforts of healthcare facilities in Southeast Asia.

Throughout the year, we celebrated the numerous awards received by many of our GGHH members in Southeast Asia and the broader Asia region from prominent national, regional, and international awarding bodies. These recognitions highlighted their various initiatives and best practices within their respective healthcare settings and communities, many of which align with the network's 10 Sustainability Agenda: leadership, chemicals, waste, energy, water, transportation, food, pharmaceuticals, buildings, and purchasing.

# Secretariat Highlights

A significant achievement of the year was the establishment of our Management Committee. Consisting of permanent program heads and the Executive Director, the committee plays a crucial role in steering the organization towards the direction and objectives outlined in the annual work plan. Additionally, it focuses on fostering staff development and organizational growth while promoting our core values.

# Administrative and Finance

#### **Milestones and Impact**

In 2023, we strengthened our team by welcoming several new members, bringing our total staff to eleven by end of the year. This added manpower has boosted all our program units, enhancing our overall capacity.

In May, our team participated in a team building workshop that focused on key human resource topics such as compassion and communication. In July, we conducted a midyear assessment and strategic planning session to set the course for the remainder of the year. We concluded the year in December with a year-end assessment and a 2024 Work Plan workshop, recognizing our achievements and planning for the year ahead.

To ensure our Board of Trustees (BOT) remained engaged and informed, the team organized three meetings with them during the last three quarters of 2023. These meetings served to keep the board updated on our ongoing and upcoming projects and to seek their feedback, ensuring their insights help guide our overarching goal.

To achieve better financial stability, the BOT approved the establishment of three funds: the Reserve Fund, the Program Support Fund, and the Staff Welfare Fund. These funds are designed to strengthen and secure finances against unexpected events, provide a source of funding for resource mobilization and program costs, and ensure the well-being and development of staff to maintain high-quality service. The implementation of these funds aims to be completed within ten years.

## **Fundraising**

Midway through 2023, we hired a new Fundraising and Development Manager. One of the first objectives was to develop a fundraising strategy aimed at enhancing our financial sustainability and expanding our donor base.

The initial phase of this strategy included two key initiatives:



#### **Fundraising Workshop**

A workshop was conducted for the staff to equip them with the necessary skills and knowledge for effective fundraising. This session covered various fundraising techniques, communication strategies, and best practices.



#### **Donor Mapping**

A donor mapping exercise was undertaken to identify potential donors and funding sources. This process involved analyzing potential donor landscapes, identifying gaps, and researching new donors who align with our mission and goals.

Although HCWH SEA did not have a historical donor base, we reached out to past project funders and partners from related initiatives, providing them with updates on our progress and exploring opportunities for renewed support. Another significant focus of our fundraising efforts for the year was directed towards securing sponsors for the 6th Green Hospitals Asian Conference (GHAC), scheduled for October 2024 in Vietnam.

As the year progressed, the fundraising strategy evolved to include more targeted approaches including outreach to new prospective donors and engagement with past project funders. By next year, the focus will be fully on fundraising for GHAC and the entire HCWH SEA.

### **Communications**

After some time of being vacated, the communications unit of the organization was finally filled midyear. The new team started with reviewing and revamping existing communication platforms, most especially social media. On top of this, the communication needs of the programs have finally continued to progress.

At the international level, the team participated in the ongoing renovation of the organization's website, collaborating with the global communications team. Regionally, efforts were directed towards re-establishing ties with communication units in allied organizations across Southeast Asia. Additionally, media engagement was reignited as we reached out to press outlets for increased media coverage.

# Challenges and Lessons Learned

Across our primary programs and support units, we have encountered common challenges and lessons in various initiatives. Manpower limitations, financial constraints, and changes in project delivery due to external factors have been part of our challenges in 2023. Nevertheless, we remained flexible and adjusted our strategy as needed to maintain a smooth workflow.

Furthermore, in 2023, we observed limited participation from some members of our networks due to competing priorities. We recognize that climate and sustainability are just a fraction of the challenges our members face, both at the health facility and health professional level. This highlights an opportunity to explore strategies that streamline engagement in our network and save time for members. For example, in the upcoming year, we plan to leverage the newly launched online course for the CIC tool to streamline our Carbon Footprint Café training for health facilities.

Consequently, we agreed that there is a need for the organization to establish more hands-on monitoring strategies and systematic recruitment techniques. Reflecting on our 2023 highlights, we have come to acknowledge the importance of more critical engagement in externally funded projects as well as the need for heightened transparency and accountability in maintaining partnerships.
